

General Terms and Conditions

General Business Terms and Conditions of Perfect Network, Inc., with its registered company headquarters at 26565 West Agoura Road Suite 200, Calabasas CA 91302 United States of America, California Corporate Number: 3420518 and the terms of Perfect Network, Inc. The General Business Terms and Conditions further define and specify the rights and obligations of the parties in concluding future sales contracts of this website www.mytrees.global.

1) General provisions

Perfect Network, Inc. hereby issues the General Business Terms and Conditions. These terms and conditions of Perfect Network, Inc. modify all relationships of Perfect Network, Inc. with all users (legal and natural persons) of www.mytrees.global. Furthermore, these terms and conditions govern all Perfect Network, Inc.'s business relationships that relate to advertising and marketing, data processing, network management, and brokerage services.

Perfect Network, Inc. is a business company: Perfect Network, Inc. with its registered office at 26565 West Agoura Road Suite 200, Calabasas CA 91302 United States of America, California Corporate Number: 3420518, represented by Vladimira Anderson, Company Director.

2) Legal relations

Any of the above relationships that are not governed by these terms and conditions or agreed in writing in a special agreement between Perfect Network, Inc. and the client, are governed by the Czech law and above all the relevant provisions of Act No. 89/2012 Coll., the Civil Code (hereinafter referred to as the "Civil Code"), as amended, Act No. 101/2000 Coll., on the Protection of Personal Data and (EU) No 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data, repealing the Directive, processing of my personal data and other related legislation.

Distinctive arrangements between the parties shall prevail over these terms and conditions.

The User, Client, or Provider hereby confirms to agree with the contents of the Perfect Network, Inc. General Terms and Conditions.

Servers are designed for legal or physical persons and all business and non-business entities, regardless of the fact that they are or may be available to persons who use them or can use them outside of the Czech Republic. Any disputes shall be resolved by the laws of the Czech Republic.

3) Definitions

A Preliminary Contract for the future purchase contract executed as per provision Sec. 1785 et seq. Sec. 2079 of the Civil Code, which binds the buyer interested in the purchase to execute a purchase contract with the Company for a specific number of designated FGT (Fast Growing Trees) or cashew trees. The company presents the various offers for the numbers of trees into packages. Concurrently, the interested buyer shall grant the Company power to sell the trees and is then entitled to a share of the payment or to sell the fruit from the cashew trees, and is furthermore entitled to a share of the payments from the sales.

The subject of the Contract is an obligation of the future seller and future buyer to execute a purchase contract upon request from the other contracting party within twelve (12) years (FGT) and twenty five (25) years (cashew tree) from the execution of the Contract at the latest. The subject of this purchase contract will be the purchase and sale of tangible items, i.e. a specific number of designated FGT or a specific number of cashew tree fruit. The purchase contract will first be executed after the GFT or the cashew tree fruit will be fit to be sold. Concurrently, the future buyer grants the future seller the authority to sell the subject of the Contract for a standard price.



These conditions are included in the Contract, as well as the consent and registration information related to the protection of personal data at MY TREES and the MY TREES Code of Ethics as amended, and together they comprise the complete agreement between the Company and the Associate (as defined below) and replace any former agreements, statements or acts.

Package

The mytrees starter package, the mytrees 1 package, the mytrees100 package, the mytrees500 package, the mytrees1500 package, the mytrees3000 package, the mytrees9000 package or the mytrees15000 package the Maranon 1 MT package the Maranon 3 MT package, or the Maranon 5 MT package.

MY TREES compensation and marketing plan

This document forms an integral part of the Agreement between the Associate and the Company. This document includes detailed information about the types of bonuses paid by the Company to Associates, and about the eligibility requirements for obtaining them, the ranges that can be achieved when moving through individual MY TREES levels, and the rewards and rewards associated with each career level. In addition, it determines the method of calculating the bonuses and the time and method of making them available to Associates.

Associate

MY TREES Independent Business Owner (IBO), who electronically through the website www.mytrees.global accepted the proposal of the agreement.

Active (business position)

Position of an Associate who has purchased any Package offered by the Company.

Permitted (business position)

Position of an Associate who has at least two personally sponsored Active Position in the Stronger Branch and at least one personally sponsored Active Position in the Weaker Branch.

Binary system

A system that divides the Associates in minimally Active Position into two teams or branches: Stronger and Weaker branch. Distribution is decided by the IBO (a particular sponsor).

MY TREES Position

Position owned or operated by one IBO under one username. Each IBO may have one (1) MY TREES position.

INDEPENDENT BUSINESS OWNER (IBO)

A natural or a legal person, who is an entrepreneur in the sense of Sec. 420(1) of the Civil Code and who owns one of the following packages: The mytrees starter package, the mytrees1, the mytrees100 package, the mytrees500 package, the mytrees1500 package, the mytrees3000 package, the mytrees9000 package or the mytrees15000 package the Maranon 1 MT package the Maranon 3 MT package, or the Maranon 5 MT package. A MY TREES entrepreneur (PMT) is not an employee, partner, proxy, representative, trader, license holder or joint venture of the Company. Some MY TREES entrepreneurs may also have a LINDEN TREE, POPLAR, OAK, BEECH, PLATANUS or SEQUOIA title, which represent ranks granted by the Company according to the conditions listed in the Compensation and Marketing Plan included in these General Terms & Conditions.

Bonuses

Direct Bonuses, Binary Bonuses and Generation Bonuses are defined in PART 4 - BONUSES.

Pools

Oak pool, Plane tree pool and Redwood pool together. All defined in PART 4 - BONUSES.

Payout period

One week. Bonuses are calculated and paid weekly on Sunday, 23:00 CET, when the system closes a week (see Point 1 in the Appendix).

WOW - volume of trades WOW

WOW is the abbreviation for volume trades created by a single IBO branch. WOW is used as the basis for bonus calculation, with 1 WOW = 1 USD. WOW is the number of packages that Associates within each team buy on the bottom line based on a two component system. The Company reserves the right to customize and modify WOW at its sole discretion.

Total volume of trades (Total WOW)

Each package purchased on the MY TREES network system has a "WOW" assigned (see previous definitions). The total volume of trades is the total amount of WOW accumulated since the Associate has reached the eligible position. Total WOW is one of the criteria used to determine the level of leadership.

Provisional volume of trades (Provisional WOW)

Each package purchased on the MY TREES network system has a "WOW" assigned (see previous definitions). Part of the total volume of transactions in the IBO branch, of which no bonuses have yet been but may be paid, is called "commission".

Required Production

The condition for paying out the commission and bonuses requires that the PMT purchases at least one (1) tree per month personally (30 days from the last purchase of a mytrees package - paid in full). If the PMT fails to do so, their position becomes inactiveTransfer

WOW from which bonuses have not been paid and has not been assigned a "failed" or "canceled" status will be transferred from one payout to the next when the position remains active. Unassigned WOW in the Stronger Branch will be transferred to the next Payout Period.



Stronger Branch

A branch in the two-component system with a larger volume of accumulated WOW in the given Payment Period.

Weaker Branch

A branch in the two-component system with a lower volume of accumulated WOW in a given Payment Period.

Bottom line

A complete set of relationships between IBO and his / her team in a two-component system. It is the pedigree of each IBO.

Generation

All IBOs who are directly sponsored by the IBO plus any person whose sponsor line comes from this IBO. The first generation IBO is the IBO you have personally registered, the second generation are IBOs which were personally registered by the first generation IBO you have personally registered.

Sponsor

The IBO, who agrees to bear responsibility for providing assistance with the trade and development of another IBO in his own generation by teaching the IBO the business, helping him, encouraging, educating, and supporting him. The "Sponsor" is also tasked with acquainting potential new IBO with MY TREES business opportunities and helping them register as a new IBO. IBOs have the ability to sponsor an unlimited number of IBOs.

Levels of leadership

Once the requirements of MY TREES Compensation and Marketing Plan are met, a person in a business position is transferred to a senior management level and is eligible for higher bonuses due to higher payout limits. These are the so-called career levels.

Maximum payout limit

This is the highest possible amount of bonuses that can be earned from the Company on a trading position for the Payout Period. Maximum amounts vary by business package type and line level.

Maximum risk exposure

This is the maximum total value of packages that IBO can own (see section 2 of the Appendix).

Personal Reference Link

The Personal Reference Link is a unique URL, which allows the PMT to send the link to potential Associates who they introduce to MY TREES.

The potential Associate who registers at www.mytrees.global by clicking on the Personal Reference Link will be placed on the team of the PMT. Subsequently, the PMT has the option to place newly registered Associates in the Binary Tree section in the My Office app.

The potential Associate registered under the PMT's name and will be sponsored by the PMT whose Personal Reference Link they used while logging into www.mytrees.global most recently.

PMT may use their Personal Reference Link in their communication, on their own personal websites, on social media sites and other online and offline products according to the rules set in the MY TREES Principles and Procedures.



Personally sponsored

Any IBO or candidate who has been registered with MY TRES by particular IBO.

Confirmed

Confirmed means that the business ID was entered in the MY TREES system at registration. The Associate does not receive any payouts until his account is "confirmed".

Fast growing tree (FGT)

Fast-growing tree species are those with a short growing season and a mass increment significantly higher than the average mass increment of other tree species. Because of their rapid growth and 'yield' they are grown as energy crops for renewable energy production, as a source of quality timber, but also for the rapid regeneration of green vegetation to improve the landscape and the air.

The dormancy period is the mean growth period after which trees in the forest are cut down. It depends on the type of forest and the rate of wood growth, which is determined by the species composition of the forest, soil quality and climatic conditions. The regeneration period is usually below 20 years for low forests and around 100 years for high forests.

Cashew tree

The cashew tree produces cashew nuts after the end of its 4th year of growth at the earliest. The reward from the sale of fruits of cashew trees is only possible for the PMT after the completion of the 4th year of growth of the cashew tree.

Business presentation

Presentation for sale of Packages.

Free trading position

The position at which the individual registers and only purchases the starter fee mytrees.

4) How can you participate?

Any MY TREES IBO whose application has been accepted and who owns the MY TREES Package may use the Company's offer in accordance with the rules hereunder.

By placing the offer for the sale of the Packages in My Office, the Company asks the entrepreneur to deliver orders in order to execute a Contract. The interested party expresses its desire to execute a Contract by sending in a filled-in form via the website. The interested party must fill in their name, surname and email address in the course of the registration process.

The Company expresses its will to conclude the Agreement by confirming the customer's order to the e-mail address of the interested party, which the interested party stated in the order.

The Agreement is made at the moment of receipt of a confirmation of the customer's order by the Company to the customer. From that moment on, the reciprocal rights and obligations arising from the Agreement and the business terms and conditions that form an integral part of this Agreement arise between the interested party and the Company.

The Agreement is concluded in the Czech or English language, the choice of the language version is the option of the interested party when filling in the order.

Participation in the Business Presentation is completely free of charge. "Free trading positions" created by fulfilling the registration process, meaning the purchase of the starter fee mytrees.



5) MY TREES Packages

Packages can be purchased during the registration process at www.mytrees.global.

The system automatically generates invoices for every mytrees Package bought. These invoices are available and can be downloaded from My Office. The invoice is authentic, contains no signature and stamps, and complies with the related legislation.

All purchases and costs are calculated in USD.

Payments for Packages are made through a transfer to the Company's account at **Raiffeisen Bank**, account number 52746306/5500 IBAN CZ805500000000052746306 SWIFT RZBCCZPP. The interested party is required to pay the price together with the correct variable payment symbol, otherwise the Company will not be able to identify the payment and provide the requested performance in time.

Packages

The Company has compiled Packages containing various items with different bonus payment limits and other benefits as well as costs related to them (see section 3 of the Annex). The package type is chosen by the buyer without any restrictions.

6) Bonuses

IBO can earn the following five types of bonuses:

- Direct bonus
- Binary bonus
- Generation bonus
- Pools
- Other rewards

Calculation of bonuses

Bonuses are calculated based on WOW. When purchasing packages, WOW is automatically counted.

Payment of bonuses

Bonuses are calculated in times and days specified by the Company, this payment schedule is described in detail in section 4 of the Annex.

7) Conditions for Bonus Payments

Terms & Conditions

At the time of bonuses, the payee's position may not be inactive. For bonuses, the position must be active for a direct bonus or eligiblefor other bonuses.

The Associate and his / her business position must meet the conditions for different types of bonuses.

Permission requirements are checked whenever the system closes a week.

Conditions for payment of bonuses to a bank account

If IBOs asks to have the money paid out through My office through until Friday midnight, they will be paid on Wednesday of the following week.

The Company has the right to review and verify the eligibility of all transactions that the IBO has made through the system. In addition,



the Company also has the right to examine all claims and liabilities arising from any other legal relationship between IBO and the Company.

If the Company has any claim against the IBO, the Company is entitled to set off this claim against the due amount that IBO requests to

pay or hold the money in custody until such claim has been resolved with the Company.

A) Direct bonus

The right to a direct bonus is created the moment an Associate purchases any package except for the mytrees starter package. Direct bonuses are immediately visible in My Office as To Be Sent.

If a trading position is not active at the time the system closes the week, Direct bonuses are not credited.

The weekly payout potential for Direct Bonuses is not limited.

IBOs have the ability to sponsor an unlimited number of IBOs.

The amount of Direct Bonuses credited varies depending on purchased Packages.

Each time the mytrees1 package is purchased, the sponsor gets 2 USD

Each time the mytrees100 package is purchased, the sponsor gets 10 USD.

Each time the mytrees500 package is purchased, the sponsor gets again 50 USD.

Each time the mytrees1500 package is purchased, the sponsor gets 150 USD.

Each time the mytrees3000 package is purchased, the sponsor gets 300 USD

Each time the mytrees9000 package is purchased, the sponsor gets 900 USD

Each time the mytrees15000 package is purchased, the sponsor gets 1500 USD

Each time the MT Maranon 1 package is purchased, the sponsor gets 8,5 USD

Each time the MT Maranon 3 package is purchased, the sponsor gets 25,84 USD

Each time the MT Maranon5 package is purchased, the sponsor gets 43,06 USD

B) Binary bonus

Binary bonuses (which are basically merchandise bonuses) are created based on the WOW associated with the Purchased Packages in the vertical line IBO.

Binary bonuses represent the following rewards:

If IBO has purchased a mytrees100 package personally, then he is entitled to a 5% of the commission WOW in the weaker branch (lower volume branch) position

If IBO has purchased mytrees500 package personally, then he is entitled to a 8% of the commissioning WOW in the weaker branch (lower volume branch) positions

If IBO has purchased mytrees1500 package personally, then he is entitled to a 10% of the commissioning WOW in the weaker branch (lower volume branch) positions

Binary bonuses can be earned only on a legitimate trading position, after the software assesses which branch of the position is weaker and thus has a lower WOW, and then calculates a Two-component bonus.

WOW, which was used in the particular week for the Weaker Branch during the Two-component bonus calculation, gets the status "used". The same process takes place in Stronger branches: WOW points equal to the WOW points used for the Weaker Branch as the basis for calculating Two-component bonuses for a particular week also get the status "Used" in the Stronger Branch.



If the trading position is not active at the time when the system closes a week, the WOW accumulated until that time is assigned a "canceled" status.

If the trading position is not at the time when the system closes a week eligible, the WOW accumulated up to that point is retained for one hundred and eighty (180) days, and at that time can be used to calculate the bonus.

If the amount of the Two-component bonuses (calculated using the described method) is higher than the maximum weekly payout limit for a particular type of trading position, as described in the appendix, only the maximum possible amount is credited.

Levels are described in detail in PART - MANAGEMENT PROGRAM

C) Generation bonus

Generational bonuses are paid out of Two-component bonuses that IBO will earn in their own generations.

Generation bonuses are paid up to seven (7) generations in depth with different percentages, based on the number of personally sponsored IBOs (see the following table).

First-level generational bonuses are paid to the sponsor for the position they are eligible for and which has in fact received a two

component bonus. Second-level generational bonuses are paid to the sponsor's sponsor for the position he is eligible for and who has in act received a 2-component bonus, etc.

The eligibility criteria for the Generation bonuses are as follows:

Business positions must be eligible, active, and eligible for Two-component bonuses.

Business positions must have the number of personally sponsored IBOs, as noted above.

8) Pools

Every time a Co-worker purchases a mytrees100, mytrees500, mytrees1500, mytrees3000, mytrees9000, MT Maranon 1, MT Maranon 2, MT Maranon 3 package, a pre-set amount from these sales is placed into three (3) different pools, whereby a percentage from each fixed amount is assigned to these pools. These pools are called an "OAK pool," a "PLATANUS pool" and a "SEQUOIA pool." Every four weeks, the amount collected in the pools are evenly divided and sent to the accounts of the Associates who fulfilled the conditions of the pool outlined below. These Associates shall receive a share, which represents a specific financial amount that is due to them from one of the pools. Periods have numbers assigned in the following format: year, forward slash and a number, which grows in increments of one depending on the period in the course of the year, e.g. 2021/1 and 2021/2 represent the first and second set of four weeks of the year 2021.



Fundamentals of pooling

Amounts collected in the pools are allocated to eligible Associates at the end of each four-week period.

Amounts collected in the pools are allocated in proportion to the shares earned.

The current pool share value is available to pool members eligible for a particular pool. (Oak Pool - 5% of Worldwide Sales, Plane tree

Pool - 3% of Worldwide Sales, Redwood Pool - 2% of Worldwide Sales).

Nominal Value of the share is relative - it is constantly changing depending on the current amount collected in the pool and also on the

current number of Associates eligible for this pool. Values can only be determined with respect to a particular moment.

There is no limit to the number of shares the Associates can obtain over any four-week period. (This means that the structure of the given

IBO is larger and larger, then the amount of share increases).

At the end of each four-week period, the shares are deposited in the bank, where the total number of shares acquired is divided into the

total pool value for determining the value of the individual shares in euro. The relevant amounts are then credited to the cash account of all eligible Associates.

A) OAK pool

Associates who have achieved the rank of "Linden", "Poplar" or "Oak" have the right to acquire shares in the OAK pool after registering at

least one (1) new personally sponsored Associate within the given four-week period.

The number of shares is calculated using the following method:

- In any four-week period, the system will review the number of newly registered Associates in generations
 of the Associate seven (7) levels in depth (this is a similar algorithm used to calculate Generation Bonuses).
- The number of newly registered Associates found in each generation is then multiplied by a multiplier that varies by depth.

An illustration of the method of calculation is the following example:

- In the given period, the amount accumulated in the OAK pool is 10,000 USD. (worldwide sales of 200,000 USD, 5% is 10,000 USD).
- In the same period, the total number of shares in the OAK pool is 1 000. (total number of shares of all eligible members 1000).
- It means that the value of the share is 10,000/ 1,000 USD= 10 USD.



The number of shares that a particular Associate can earn is calculated as follows:

It follows that in the given four-week period, the ASSOCIATES is entitled to a total of 98 shares, which means that the Associate's money account will be credited with 98 x 10 USD, that is 980 USD.

B) PLATANE TREE pool

Associates who have achieved the "BEECH TREE" or "PLANE TREE" rankings will be eligible to receive a PLANE TREE pool after receiving their own two-component bonuses each week in the four-week period when the system closes a week.

The number of shares is calculated using the following method:

- The basis for the calculation is the amount of Generational bonuses that the Associates have received.
- During the given period, each \$ 1 earned by Generational bonuses (including those listed as Pending Waiting at My Office) has one (1) share in the PLATAN pool (for example, A registers B and receives \$ 1000 in a two-component bonus, so A belongs to 3%, i.e. 30 USD, and it equals 30 shares in the Platinum pool).
- The number of shares can be in decimal numbers. It is reasonable to use two (2) decimal numbers. For example, \$ 4.58 in Generation Bonuses equals 4.58 of a share

An illustration of the method of calculation is the following example:

- The amount accrued in the PLATAN pool is 10,000 USD in the given period.
- In the same period, the total amount of generational bonuses is USD 1,000, so the total number of shares is 1,000.
- The value of share is 10 000/1 000 USD= 10 USD.
- *— The number of shares that a particular Associate can earn is calculated as follows:*
- If the Associates earns 20.5 USD in Generation Bonuses, then this Associates is entitled to 20.5 shares in the PLATAN pool.
- This means that in the given 4-week period, the Associate's cash account will be credited with \$ 20.5 x 10, or \$ 205.

C) Redwood pool

Associates who have achieved the "REDWOOD" rank will be eligible to receive shares in the REDWOOD pool after receiving their own Two-component bonuses each week in a four-week period when the system closes a week.



The number of shares is calculated using the following method:

- The basis for the calculation is the amount of the binary bonus received by the Associates in the given four-week period
- In the four-week period, each one dollar earned by two-component bonuses (including those listed as Pending in My Office), has one share in the REDWOOD POOL (Jana receives \$ 1000 from a two-component bonus in the observed period – that means she has 1000 shares in the REDWOOD POOL).
- The number of shares may be two decimal numbers, for example \$ 10.28 in two-component bonuses equals to 10.28.

An illustration of the method of calculation is the following example:

- In particular period, the amount accumulated in the REDWOOD pool is 10,000.USD
- In the same period, the total amount of binary bonuses of eligible persons is 2000 USD, i.e. the total number of shares is 2000.
- The share value is USD 10,000 / 2,000 USD = USD 5.
- The number of shares that a particular Associate can earn is calculated as follows:
- If an Associate earns \$ 55.5 in two-component bonuses, then this Associate is entitled to 55.5 shares in the REDWOOD pool.
- It follows that in the given four-week period, the Associates' cash account in the example will be credited with 55.5 x 5USD = 277.5 USD

9) Other rewards

The Company may announce MY TREES competitions from time to time as well as motivational programs and rewards. PMTs are always informed on the conditions for participation in these competitions via newsletters emailed by the Company to those PMTs registered to receive them. Once the announcement is made, these conditions on participation will also be available via My Office. Prices are non-transferrable and cannot be paid out in cash. Every MY TREES competition and competition program sets its own rules in detail.

10) Management program

Achieving a higher level of leadership or rank allows IBO to earn more money because as IBO progresses with our system, the maximum weekly bonus payout limits increase. In addition, eligible IBO will receive access to various incentive rewards.

In order to obtain management authorization, the following criteria are examined:

The trading position must have the amount of WOW collected in its weaker branch, as shown below in the table;

Business positions must have a number of leaders in their bottom line, as listed below in the table.

*This rank can reach trading positions with packages at least mytrees100 or mytrees500. POPLAR or higher positions can only reach trading positions with the mytree1500 package.

Note: If you see two boxes in the same color in the RANGE row in the above table, it means that both branches must have a minimum number of IBOs with a particular rank.

11) Associated costs

Free business presentations

Participation in our business presentation is a mandatory requirement in order for you to apply for the IBO status. This step is completely free of charge, so everyone has the opportunity to learn about the possibilities of doing business with MY TREES without having to pay for it. We do not charge any fees or charges for any business presentation, nor any third party, whether or not it is affiliated with us, so no one is entitled to receive money from participants and registered persons for these services.

Costs of commission payments

IBO will receive its bonuses on its bank account under certain conditions including certain fees set by the Company (as defined in section 5 of the Annex).

Cost of unsuccessful bank transactions

The Company charges payment fees. In the event that the bank details that the IBO stated in the system are incorrect and therefore the required money transferred to the IBO account is returned, the Company has the right to charge the IBO the costs incurred in connection with the transaction and to reduce IBO's payout amount.

Indirect costs

In addition to the above costs, IBO may also incur indirect costs associated with your MY TREES business, such as telephone and Internet charges, travel, event organizing costs, training and training materials, etc. In any case, IBO costs are paid by IBO. 12) Termination of the Agreement

The Company is entitled to terminate the contract immediately without the IBO having to pay any compensation if:

IBO will be bankrupt or a bankruptcy petition will be filled with the court;

IBO (as a legal entity) will be terminated;

IBO 's fault will create a situation that affects the reputation of the Company;

IBO does not fulfill one or more of its obligations under the Agreement or other agreements with IBO or its affiliates, even after providing a reasonable period to ensure fulfillment of its obligations.

IBO is more than 30 days late with payment.

If a force majeure event occurs and as a result the Company will not be able to fulfill its obligations and determine that services will not be available beyond six months from that date, IBO and the Company will each be entitled to withdraw from the agreement on written notice. In the case of force majeure, compensation for possible IBO damages is excluded.

13) Other provisions

The applicant agrees to use distance means of communication when concluding the Agreement.

If certain parts of these terms and conditions are ineffective or unfeasible, the effectiveness and feasibility of other terms remain unaffected. Thereafter, a condition that is as close as possible to the economic substance of an ineffective or unenforceable provision applies to the parties.

Relationships and possible disputes between the parties will be settled exclusively under the laws of the Czech Republic and will be dealt with by the relevant courts of the Czech Republic.

Annex 1

1. Week closing

The system closes each week every Sunday at 23:00 Central European Time (CET).

2. Maximum risk exposure

The company has set limits that, if exceeded, could cause excessive risk exposure. This limit is fifteen thousand dollars (15,000 USD), which is the maximum total value of the packages that can be purchased from the Company by an IBO registered as a natural person or as a natural person - independent business owner. This limit does not apply to an IBO who is registered as a legal entity.

1) Introduction and Statement

- A. In this Code, a "MY TREES Member" is a User or an Associate as defined in the General Terms & Conditions, which are, just like this Code, an integral part of the Preliminary Contract for the future purchase contract executed between a MY TREES Member and Perfect Network, Inc. with a seat at 26565 West Agoura Road Suite 200, Calabasas CA 91302, United States, California Corporate Number: 3420518 (hereinafter referred to as "Company").
- B. "Product" covers all tangible and intangible services and products sold and purchased as part of the MY TREES project.
- C. "Direct Sales" means direct sales between a seller (Member of MY TREES) and an interested party based on a personal meeting and presentation of a Product.
- D. "MY TREES Project Presentation" is the Direct Sale to a group of interested parties in order to present and sell a Product.

The purpose of this Code is to define and maintain generally accepted ethical principles, the development of positive relationships between the Company, MY TREES Members and potentially interested parties, support of fair competition with a goal of preventing any type of illegal behavior. These principles are described briefly in the sections below in this document.

The MY TREES project membership may only be granted and can continue if it is in full accordance with this Code.

2) Forbidden Behavior

3) Proof of Identity

MY TREES Members are obligated to truthfully, and without being asked to do so, indicate their identity as well as the identity of the Company, the nature of the products and the purpose of their offer to potentially interested parties at the start of the business presentations. In the event of a Project Presentation, MY TREES Members shall clarify the purpose of the event to the host and participants beforehand, i.e. prior to starting the actual presentation.

4) Explanation and Presentation

MY TREES members are obligated to accurately explain and present the "Product," which is the subject of a business transaction as part of the MY TREES platform, to the interested parties in full scope including the price, payment deadline and form of payment, rights to withdraw from the contract, return options, after-sale service, delivery deadlines, and to to provide them with the Business Terms & Conditions so they can familiarize themselves with their contents. MY TREES Members shall respond to all questions of interested parties accurately and coherently. If MY TREES Members make a claim regarding a Product, whether it be verbally or in writing, then these claims must be previously approved by the Company. MY TREES Members shall act in accordance with applicable law and, provided that a MY TREES Member becomes aware that they are dealing with a consumer in the course of their business persons. At the same time, MY TREES Members are obligated to comply with all statutory obligations under Act No. 634/1992 Coll., on consumer protection. If they delegate direct sales to other persons, MY TREES members are obligated to inform these persons of their legal obligations under the relevant legislation and to acquaint them with the contents of this Code.



5) Order Form

MY TREES Members provide the interested parties with an order form the moment the first sale is made or potentially, prior to it taking place. If the sale is made over the phone, on the internet or through similar indirect channels, it is necessary to provide them with the order form prior to the fact or to add it to the initial offer, or make it available online to be printed or downloaded.

6) Promotional Materials

MY TREES Members are authorized to use official promotional MY TREES project materials only. These are available for this purpose in My Office / Downloads. MY TREES Members are not permitted to use other than the official MY TREES project materials, which were provided to them by the Company for this purpose.

7) References

MY TREES Members shall not use any references or other recommendations, which are not approved by the Company, which are untruthful, outdated or otherwise invalid and which do not relate to the offer. References and other recommendations are never used in a misleading manner.

8) Comparisons and Pricing

MY TREES Members are obligated to refrain from comparisons, which could be misleading or which do not comply with the principles of fair competition. Comparisons may be made only according to provisions in Act. No. 89/2012 Coll. of the Civil Code on permissible comparative advertising. MY TREES Members are not entitled to directly or indirectly defame other entities, persons or products. MY TREES Members are not entitled to unfairly use the goodwill associated with the trade name and symbol of another company or product. MY TREES Members acknowledge that the relevant provisions regulating unfair competition under Act No. 89/2012 Coll., of the Civil Code, apply to their activities. MY TREES members shall not, in the course of their business dealings, unfairly defame or allow their direct sellers to unfairly defame the products, sales and marketing plans, or other affairs of other companies, and shall not allow their direct sellers to engage in similar unfair defamation.

9) Privacy Protection

Personal contacts as well as telephone and email contacts shall be made appropriately and at an appropriate time so as not to disturb the other party and that they comply with relevant legal regulation. MY TREES Members are obligated to stop the presentation or sale the moment the interested party asks them to do so. MY TREES members are obliged to take appropriate steps to ensure the protection of all personal data provided by existing or potential interested parties in accordance with the relevant legislation, in particular Act No. 110/2019 Coll. on the processing of personal data and REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016.

10) Honesty

MY TREES Members are not entitled to abuse the trust of individual interested parties, are obliged to respect any lack of business experience and are not entitled to take advantage of an interested party's age, illness, mental or physical weakness, gullibility, lack of understanding or lack of language skills.

11) Sale Similar to Other Recommendations

Neither the Company nor MY TREES Members may persuade an interested party to purchase a Product on the basis that the interested party can reduce or refund the amount paid for the Product they are offering.

12) Fair Conduct between MY TREES Members

Each member of MY TREES shall act honestly, fairly and in accordance with good morals in their dealings with other members of MY TREES. They shall refrain from any action that could harm or cause harm to another



MY TREES Member. They shall also refrain from any interference with the activities of another MY TREES Member where it is likely to interfere with their activities.

13) Good Name of the Company

MY TREES Members undertake to act at all times during their membership and in the performance of related activities so as not to bring the Company's good name and reputation into disrepute. They shall act in accordance with the legitimate interests of the Company.

Any actions that violate the above principles of conduct of MY TREES Members may be grounds for immediate termination of the contract in accordance with the General Terms and Conditions. The Company reserves the right to amend the Code if necessary.
